

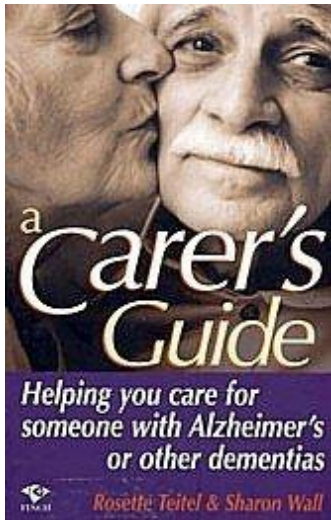

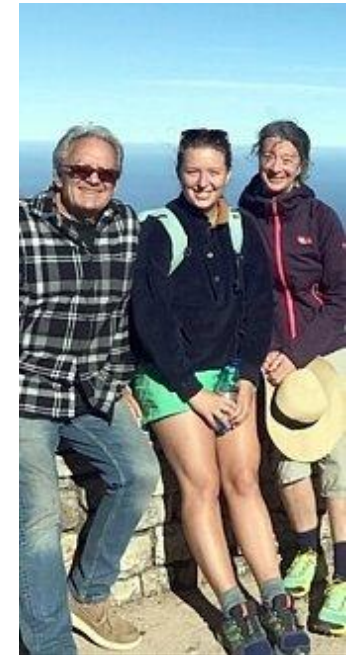

● **Rosette Winger** (*LSY: Terminale in 1959*) told us that she “ had her first book published under the name of Rosette Teitel by Rutgers University Press in 2001. Its title is *THE HANDHOLDER’S HANDBOOK, A Guide for Caregivers of People with Alzheimer’s or Other Dementias*. It was subsequently republished in Australia under the title *A CARER’S GUIDE, Helping You Care for Someone with Alzheimer’s or Other Dementias*. (Sharon Wall is listed as co-author since she was the expert on the differing health, social security, and other laws in that part of the world). More recently, Rosette’s name appears on *I DID SOMETHING ABOUT IT, Overcoming Life’s Hardships*, by Foriz Uddin. She did the writing on behalf of Foriz. Aside from that, she still teaches ESL (right, French was no longer in great demand!) part-time to adults in her local community college. She also volunteers to play Scrabble with a one-hundred-and-two-year old woman once a week.”

● **Jean-Didier Sicault** (*LSY: Terminale in 1959*) is a "Senior Lecturer in International Civil Service Law at the University of Paris II, and member of the Board of Editors of the Revue Générale de Droit international Public.....Attorney (Paris), former Legal Counsel of ACCT (ancestor of the International Organization of the French-Speaking World), he advises the Management of some international organizations, concerning issues related to international civil service law and above all, privileges and immunities. However, since more than 30 years, he dedicates most of his work to advise, negotiate in favour of, and litigate on behalf of, staff members, as well as Staff representative bodies (associations and unions) of some 90 international organizations. In that framework, he has brought cases before 15 International Administrative Tribunals (in particular those of the UN, the ILO, the Coordinated Organizations, the International Financial Institutions, etc.) for the benefit of staff. He has notably devised and implemented FICSA’s Legal Defence Strategy which has given rise, at the end of the 1980’s, to more than 30 judgments of UNAT and ILOAT, notably on acquired rights. Areas covered : contracts (appointments, non renewals, terminations, policies), performance assessments, transfers, rotation policies, secondments, advancement, promotion, post classification, disciplinary actions, harassment (mobbing, sexual harassment)" (<http://www.jeandidiersicault.com/>)

● **Bernard Eichi Moffroid** (*LSY: 6eme in 1953*) has been the owner and chef of the Café Bernard in Basalt, Colorado, since 1990. Their timing proved perfect. In addition to building a loyal local clientele, Basalt's growth as a second-home town and its emergence as a golf resort provided more of the type of dinner customers Cafe Bernard targeted. Basalt eventually became a hot spot in the valley for restaurants. 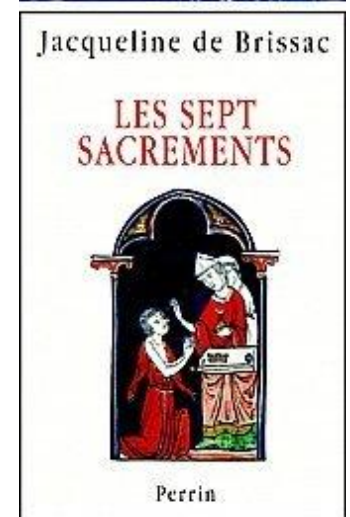
- **Michael Bleier** (LSY: 2nde in 1957) wrote: "I met my wife in Washington DC in December 1965 and we were married on October 9, 1966. We have three children, Tommy, Lisa and Mark, and eight grandchildren. We are still married and while I still practice law, primarily bank regulatory law, we also take time to travel in the US and overseas.

After Georgetown Law, I started working at the FTC. In 1971 I joined the Federal Reserve Board's Legal Division and left in 1982 as an official of the Board, as Assistant General Counsel responsible for the bank holding company/banking structure group in the Legal Division.

In 1982 we moved to Pittsburgh and I started working for Mellon Bank. I stayed there until October 2006. ● **Antoine J. Polgar** (*LSY: 1ere in 1958*) wrote: "Antoine J. Polgar, adjunct French instructor at CDL and an Empire State College alumnus, has self-published a volume of poetry. Titled "Chronicles & Elegies," the work by the French-born American poet is, in his own words, "an anachronistic narrative of transatlantic memoir, nostalgia and a Euro-American sensibility forged out of a convergence of poetic genres and forms; the epic of contemporaneity shaped by the historical imagination, the lyric of experience and elegiac allusion - with the classical rhetoric instruments of apostrophe, imprecation and synecdoche."

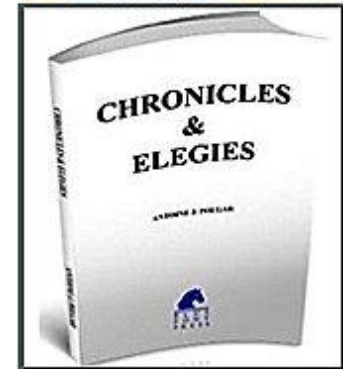

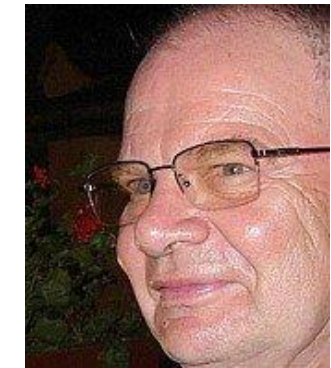

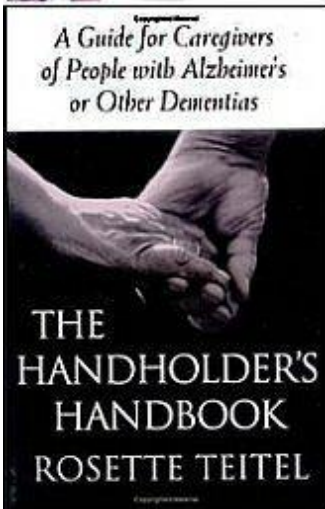

Michael Bleier wrote: "I spent three years at the University of Tulsa and enjoyed living in a totally different part of the US with a very different perspective on current events. My parents moved to Tulsa because of my father's job and because I was 16 when I started at NYU, I moved with them. I had the good fortune of having as my roommate Hafiz Nawabi, who was from Kabul, Afghanistan. He now lives in the Washington, DC area and we have remained extremely close, attending each family's special events.

I graduated from Georgetown Law in 1965 and studied for almost two years at Johns Hopkins' SAIS, which I left to go into my brief military service. In the interim I got engaged after four months and married in October 1966, and Phil Schreiber, a Lycee classmate, was best man at my wedding. My wife is a writer of corporate histories and we have three children and eight grandchildren.

I worked at the FTC for about three and a half years and then went to the Federal Reserve Board's

Legal Division in Washington, DC where I stayed for eleven years. I left as Assistant General Counsel and joined Mellon in 1982. I have been here ever since and have been General Counsel for the holding company and bank since 1992. I have been on the Senior Management Committee since 1992. As General Counsel I am responsible for the day-to-day operations of Mellon's Legal Department and supervise a staff of 69 lawyers at 12 locations. During my time at Mellon I have been responsible for the legal aspects of the Corporation's expansion in both the banking and nonbanking areas, regulatory matters, dealings with the Congress and state legislatures.
